Dear Neighbour,

Welcome to our first quarterly newsletter dedicated to updating our local community on current construction activities at the Audley Square Redevelopment. This newsletter sits alongside our Annual Public Exhibitions and Monthly Neighbour Liaison Meetings, forums for us to engage with you and to update you on site progress and upcoming works (further details in this newsletter).

Careys Civil Engineering has been appointed to carry out the Basement Box and Frame Works Package. We will commence on site at the end of July 2020 and our package of works is expected to complete in early 2023.

As a member of the Considerate Constructor's Scheme, we are committed to informing and respecting our neighbours and the local community. We will work closely with Westminster City Council, consulting with them on key issues affecting local residents. Our project will be monitored by WCC's Code of Construction Practice, which sets out the standards and procedures to which construction projects must adhere.
