NEIGHBOURLY NEWSLETTER #5 CONSTRUCTION UPDATE

Dear Neighbour,

We hope this newsletter finds you well. Since our last letter, the world has opened up more and we hope you enjoyed a decent summer.

Over the summer months, our project has achieved a great deal! We completed our piling programme back in May and demobilised our three piling rigs. Ground Source Heat Pump works are now complete and we welcomed the installation of our first Tower Crane back in August. We've now commenced our hybrid construction phase, including Basement Excavations and the construction of our Ground Level Traffic Slab that will enable us to improve traffic management around our site. Peruse the rest of this newsletter to find out what construction activities are coming up in the remainder of 2021

We also want to reconfirm that we are committed to being considerate contractors and respectful neighbours. We continually review and improve our practices to ensure we are respectful of the local community. Some of these considerations include: operating quieter periods between 10:00–12:00 and 14:00–16:00, continuous environmental monitoring (noise, dust, vibration), measures to dampen noise and dust, using more sustainable electronic machines where possible and registering with the Considerate Constructors Scheme, to name a few.

We are about halfway through our programme and we look forward to working with you to achieve a successful completion of our works.
