Welcome to the latest newsletter from the site team at Audley Square House Project, with the intent to inform of site activities undertaken to date and of future works.

I am happy to report that progress has been excellent in the last month:



The former car-park

Demolition of the two-number underground car-park slabs is underway. The debris generated from this demolition is being removed from site by excavator into tipper lorries. The environmental emissions being controlled with water suppression, acoustic screens, and careful loading techniques.



The Ascott Hotel

Demolition of the remaining ground floor has started now that the existing substation has been isolated.

4 Audley Square

We have made good progress with the under-pinning in this area.

Utility Services diversions

Externally, various statutory utility supplies have been diverted and rerouted and are ongoing. We continue to coordinate our works with this highway work, being undertaken by other, to minimise any impact.

Future Site Works

Works will include the demolition of the remaining Ascott Hotel and car-park structure now that the substations are no longer live, and start the selective demolition of the basement slabs.

Traffic Management

We shall continue to maintain our Traffic Management Team to supervise the site traffic and deliveries, particularly while the highways infrastructure works are being completed to the site perimeters.
